Devices containing lithium metal or lithium ion batteries should be carried in carry-on baggage. For more information to portable electronic devices, see the FAA regulations. Aerosol insecticides are not allowed in carry-on; however they are allowed in checked bags as long as they are not labeled as hazardous material (HAZMAT). Devices. Other battery types, such as alkaline or nickel-metal hydride (NiMH), are generally considered safer to ship. Please take a few minutes to read the below page thoroughly, including the lithium battery prohibitions section. 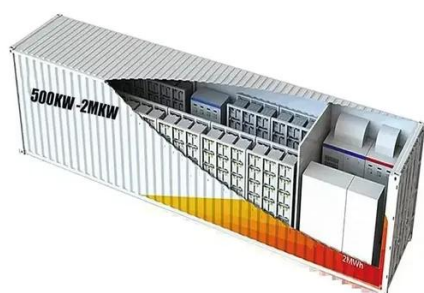
