Overview

The documentation process, for example, passports, visas, power of attorney, etc., can take one week to 14 days plus the transportation – airfreight – seven to 21 days / weeks and ocean – six to eight weeks, depending on the origin. Corruption remains a major factor in clearing products through customs. Guinea launched a one-stop-shop online portal to facilitate foreign trade, called the Guichet Unique du Commerce Extérieur de Guinée. This portal digitizes commercial transaction management, facilitates customs declarations.

- Local currency equaling 100,000 GNF can be exported out of the country and approximately 5000 in Euros or similar foreign currency.
- Residents and non residents alike can import up to 100, 00 Guinea Francs providing they have an export declaration equalling the amount brought in.

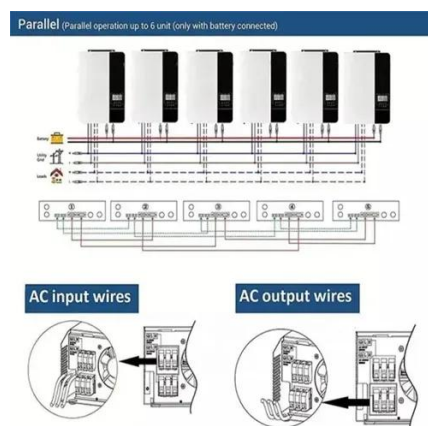

CUSTOMS REGULATIONS AND INFORMATION FOR IMPORTS

Customs levies an "RTL Tax" or 2% of cost, insurance and freight (CIF) value, with a minimum of 300.000 GNF (approximately 30 Euro), applicable to all shipments.
