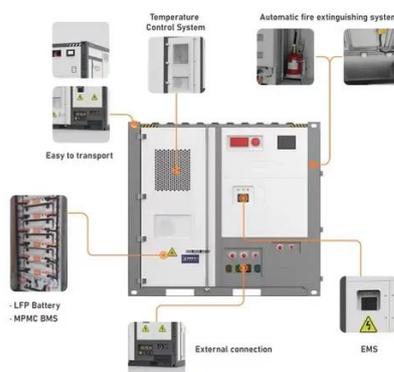



Unequal access to solar energy raises ethical concerns. Communities with limited resources may face barriers in adopting solar technology, resulting in disparities in energy access.


