Through Communities in Charge, facilities that serve the public, including multi-family housing sites, are eligible to receive up to \$6,500 or 100% of the cost of deploying a level 2 electric vehicle (EV) charger. The California Public Utilities Commission's (CPUC) Self-Generation Incentive Program (SGIP) offers incentives for installing energy storage and paired solar technology at low-income households. To support customer resiliency and grid reliability, the CPUC has authorized funding of \$280 million for. Community ownership of assets is one way to deliver a more equitable distribution of benefits and control in the energy sector. Energy storage in particular can be adopted at the local level due to the flexible and scalable nature of the technology. The program reduces greenhouse gas emissions and household energy costs by saving energy and generating clean renewable power. When combined with a federal tax credit, the program's financial incentives are.
