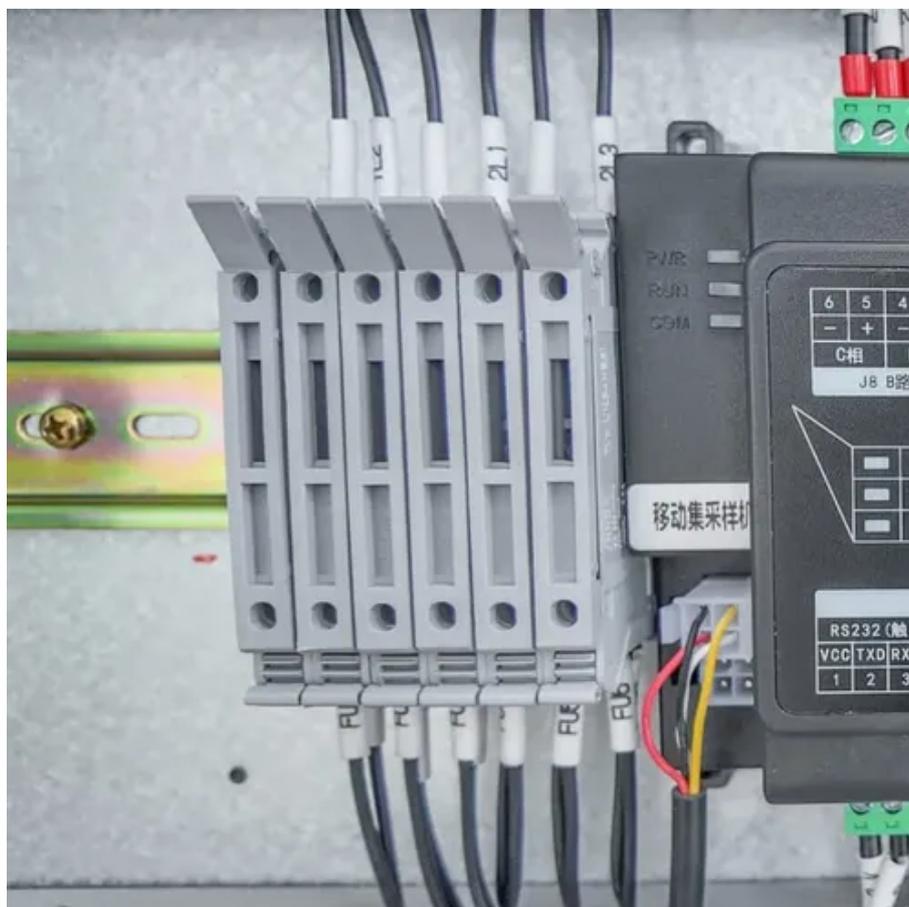




Disabled people can install solar panels

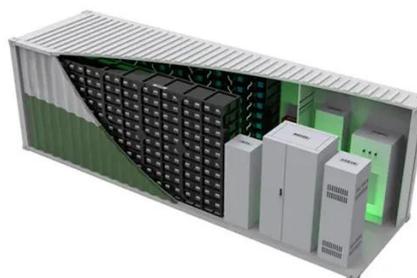
