If you install solar energy equipment in your residence before the end of 2025, you're entitled to a nonrefundable credit off your federal income taxes equal to 30 percent of eligible expenses. If you invest in renewable energy for your home such as solar, wind, geothermal, fuel cells or battery storage technology, you may qualify for an annual residential clean energy tax credit. The Residential Clean Energy Credit equals 30% of the costs of new, qualified clean energy property for your. The solar tax credit allows homeowners to subtract 30 percent of the cost of installing solar heating, electricity generation, and other solar home products from their federal taxes. According to EnergySage, an alternative energy marketplace, it costs about \$28,000 to install a typical system. The credit for solar upgrades was extended through 2025, empowering more homeowners to switch to solar. Solar panels are less expensive than their list price because of a 30% federal tax credit.
