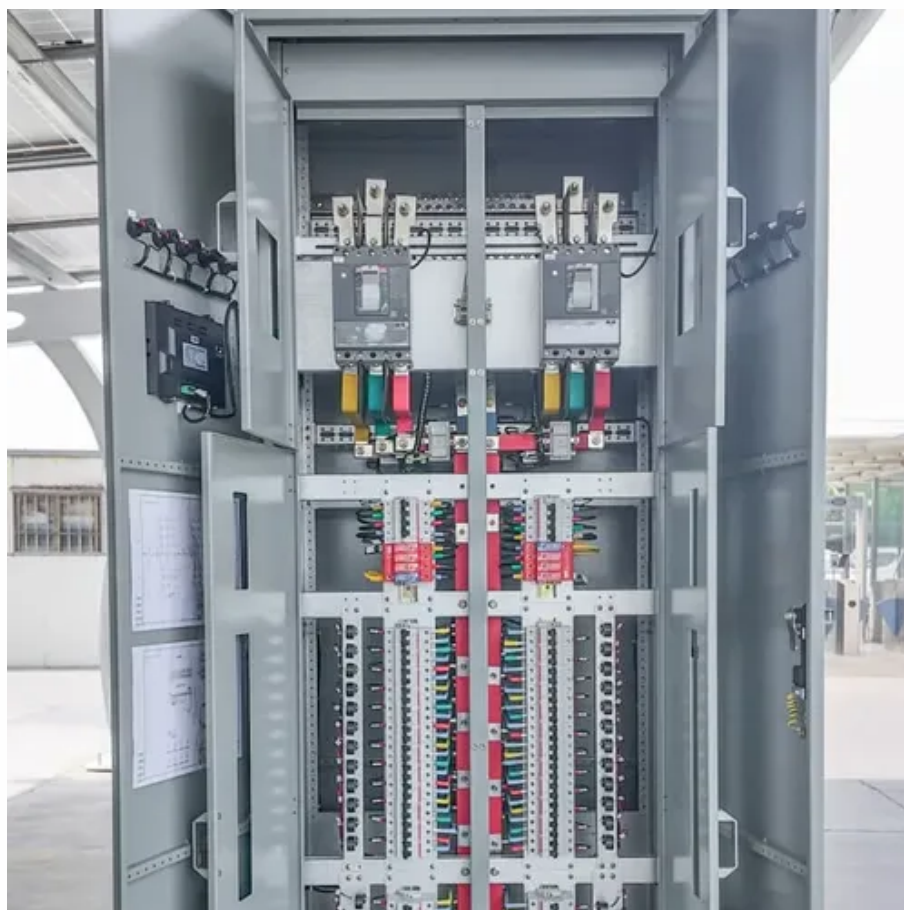




New Energy Storage Project Consultation Meeting



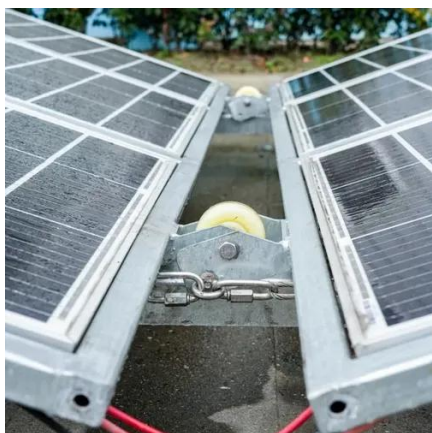


Overview

The consultation will run from February 26 through April 11, 2025. The proposed methodology quantifies greenhouse gas (GHG) emission reductions from the operation of grid-connected energy storage systems to prioritize greater emission reductions over maximizing net revenues. The CEC has announced a public meeting for a proposed battery storage project that is seeking approval through the Opt-In Certification program.
