Overview

Our standard contracts and securitization resources include example contracts, operation and maintenance guides, and a mock filing with ratings agencies for photovoltaic (PV) systems. 1 Under an EPC Contract, a Contractor is obliged to deliver a complete facility to the Project Company. The Project Company needs only to turn a key to start. The EPC Contractor agrees herewith to specify or require, or unless otherwise defined in the Master Agreement, any circumstance or event that is expressly designated herein as a "Client Risk" approved by Client, to be executed by EPC Contractor as part of the project schedule. A working understanding of contract development best practices and access to standardized solar contract templates and request for proposals (RFPs) will help reduce the time and cost associated with this process by improving project transparency and accountability while accelerating solar. This EPC contract contemplates that a single contractor will be responsible for the entire project -- from design through construction and testing. These resources were developed by an NLR-led working group—convened from the solar, finance, and legal. Most utility-scale solar projects use an EPC Contract.

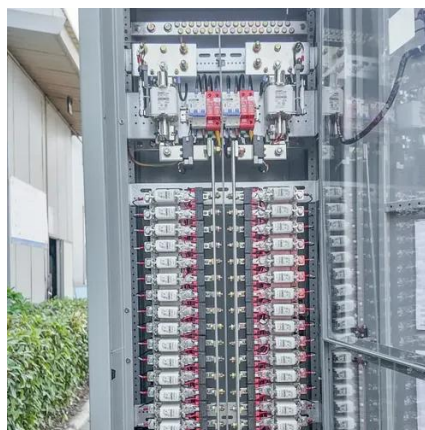
