The Residential Clean Energy Credit allows you to claim a deduction for the cost of new clean energy property, including solar panels. The credit for solar upgrades was extended through 2025, empowering more homeowners to switch to solar. If you invest in renewable energy for your home such as solar, wind, geothermal, fuel cells or battery storage technology, you may qualify for an annual residential clean energy tax credit. Any system installed after this year won't qualify for the discount that's helped millions of households cut thousands off their installation costs. On July 4, 2025, President Trump signed into law Congress's budget reconciliation bill, H. 1—commonly known as the One Big Beautiful Bill. This legislation brings significant changes to the federal tax credit for residential and commercial solar and battery systems. Find out if you qualify and learn how to claim the solar tax. 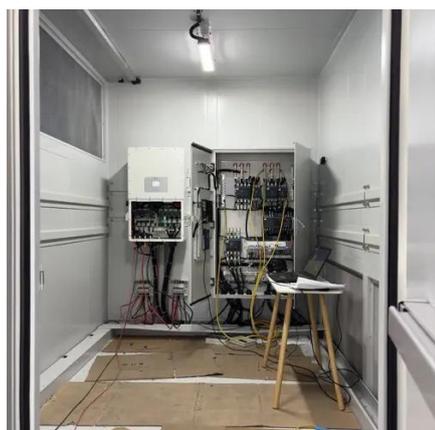
Think of the credit as a straight 30% cut on the total price of your residential solar project. Take your all-in cost and multiply by 0.30. That number reduces your federal income tax bill
