Venezuela tariff rate is 15%. However, this rate can vary depending on the specific product category and any applicable trade agreements or exceptions. How do Venezuela tariffs affect import costs?

Venezuela tariffs directly increase the cost of importing goods by 15%. In early April 2025, the United States enacted sweeping “reciprocal tariffs” on imports, aiming to mirror (at a discounted rate) the trade barriers faced by U. 

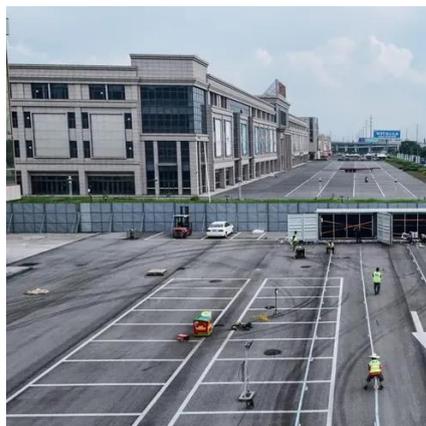


Venezuela Tariff Rate , TariffCheck
